Query/Issue	BAC/End-User Response/Clarification
One of the bidder's representative asked for clarification on Lot 1 for 64GB memory specification as the items do not have do not have the exact memory capacity?	TWG clarified that the memory specifications are based on the capacity stated in the item label.

Query/Issue	BAC/End-User Response/Clarification
A bidder representative asked if bid securing declaration is acceptable	BAC Chairman confirmed that bid securing declaration is accepted (page 98 of bid docs).
A bidder representative asked for clarification stating that there are no specs of class 10 for OTG flash disks, only USB 2.0 or 3.0.	TWG stated that it is USB 3.0 because it is specified as type C, and that the items should have the specified 80Mbps transfer speed.
Whether it is possible to submit bid documents through courier?	BAC Chairman answered that submission of bid documents is acceptable provided that these will be received by the BAC before the deadline set prior to bid opening.
Whether on line payment for the bid documents is possible and if suppliers may join the bid opening online.	Bank details will be emailed for online payment method. Bid opening will have an online platform provided.
Whether it is acceptable even if the tax clearance does not have expiry date because it was renewed online.	BAC Chairman stated that it is accepted.
One of the bidder's representative asked for clarification about envelope whether it is the same for lots1 and 2.	Envelope 1 (Eligibility) is the same for lots 1 and 2 but there should be separate envelope 2 (Financial) for lots 1 and 2.
