RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF VENUE WITH ACCOMMODATION AND FOOD DURING THE 2022-2024
REGIONAL ACCOUNTS OF THE PHILIPPINES NEWS CONFERENCE (MORNING) AND FOCUS
GROUP DISCUSSIONS (FGD) ON CONSTRUCTION TOWARDS THE OVERALL REVISION AND
REBASING OF THE PHILIPPINE SYSTEM OF NATIONAL ACCOUNTS FOR LOCAL
GOVERNMENT UNITS (AFTERNOON) ON 22 APRIL 2025, AND FGD FOR PRIVATE SECTOR
ON 23 APRIL 2025 BE AWARDED TO GOLDEN PRINCE HOTEL AND SUITES

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue with accommodation and food during the 2022-2024 Regional Accounts of the Philippines News Conference (Morning) and Focus Group Discussions (FGD) on Construction towards the Overall Revision and Rebasing of the Philippine System of National Accounts for Local Government Units (Afternoon) on 22 April 2025, and FGD for Private Sector on 23 April 2025;

Whereas, the Purchase Request (<u>PR No.0700-2025-04-033)</u> with an Approved Budget of Contract (ABC) of Two Hundred Two Thousand Six Hundred Pesos Only (Php202,600.00) was received by the Regional Office 7 Bids and Awards Committee (R07-BAC) on 07 April 2025;

Whereas, as approved by the Head of the Procuring Entity (HOPE) through RO7-BAC Resolution No. 0700-2025-04-R160A dated 15 April 2025, this procurement was done through Lease of Venue;

Whereas, the RO7-BAC received quotations from two (2) suppliers: 1) Golden Prince Hotel and Suites and 2) Harolds Hotel; and one (1) not available from Deped Ecotech Center, a government-owned establishment, as stipulated in the abstract of quotation;

Whereas, the RO7-BAC considered the quotation submitted by Golden Prince Hotel and Suites as the Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the RO7-BAC declares Golden Prince Hotel and Suites with the Lowest Calculated and Responsive Quotation (LCRQ);

**Now, THEREFORE,** be it resolved as it is hereby resolved that the members of Regional Office 7 Bids and Awards Committee (R07-BAC) present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the procurement of Venue with accommodation and food during the 2022-2024 Regional Accounts of the Philippines News Conference (Morning) and Focus Group Discussions (FGD) on Construction towards the Overall Revision and Rebasing of the Philippine System of National Accounts for Local Government Units (Afternoon) on 22 April 2025, and FGD for Private Sector on 23 April 2025 be awarded to **Golden Prince Hotel and Suites**.
