RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) FOR THE PROCUREMENT OF DOOR TO DOOR FORWARDING AND DELIVERY SERVICES FROM PHILIPPINE STATISTICS AUTHORITY, PSA COMPLEX, EAST AVENUE, DILIMAN, QUEZON CITY TO PHILIPPINE STATISTICS AUTHORITY-CENTRAL VISAYAS AREA BE AWARDED TO CREST FORWARDER INC.

Whereas, the Philippine Statistics Authority (PSA)-Regional Statistical Services Office 7 is in need to procure Door to Door Forwarding and Delivery Services of Various ICT Equipment from Philippines Statistics Authority, PSA Complex, East Avenue, Diliman, Quezon City to Philippine Statistics Authority-Central Visayas Area;

*Whereas, an approved Purchase Request with **PR No. 0700-2023-02-016** was received by the R07-BAC Secretariat;*

*Whereas, the Approved Budget for the Contract (ABC) for the said procurement is **ONE HUNDRED THIRTY FIVE THOUSAND PESOS ONLY (135,000.00)**;*

Whereas, this procurement was posted at the Philippine Government Electronic Procurement System (PhilGEPS) website, Philippine Statistics Authority (PSA) website, and in three (3) conspicuous places in compliance to the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 otherwise known as the Government Procurement Act on 22 FEBRUARY 2023 with reference no.9502200;

Whereas, this procurement was done through Alternative Method of Procurement – Small Value Procurement;

Whereas, the Region 7 Bids and Awards Committee (R07-BAC) received three (3) qualified bid forms from registered establishments namely;1.) Libcap Super Express Corporation 2.) LBC Express Inc. and 3.) Crest Forwarder, Inc.

Whereas, the Region 7 Bids and Awards Committee (R07-BAC) with the presence of the member of the Technical Working Group (TWG) conducted a deliberation on 01 March 2023;

Whereas, during the opening of bids, R07-BAC considered the quotations submitted by Crest Forwarder as the Lowest Calculated Quotations (LCQ) subject for verification as it is a new Supplier to PSA RSSO 7;

Whereas, a verification was conducted a personal interview and the result was presented by the TWG to the R07-BAC on 15 March 2023 Crest Forwarder Inc.is responsive and can comply on the laid technical specifications;

Whereas, after thorough evaluation, the R07-BAC declared the Crest Forwarder Inc. as the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved that the members of the Region 7 Bids and Awards Committee (R07-BAC) who were present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that this procurement of Door to Door Forwarding and Delivery Services of Various ICT Equipment from Philippines Statistics Authority, PSA Complex, East Avenue, Diliman, Quezon City to Philippine Statistics Authority-Central Visayas Area be awarded to Crest Forwarder Inc.
