RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF VENUE WITH ACCOMMODATION AND FOOD (PM SNACKS, BUFFET
BREAKFAST, BUFFET LUNCH, AND BUFFET DINNER) DURING THE SECOND LEVEL
TRAINING PLDS DATA PROCESSING ON 6-8 AUGUST 2024 BE AWARDED TO GOLDEN
PRINCE HOTEL AND SUITES

WHEREAS, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue with Accommodation and Food (PM snacks, buffet breakfast, buffet lunch, and buffet dinner) during the Second Level Training PLDS Data Processing on 6-8 August 2024;

WHEREAS, the Purchase Request (<u>PR No.0700-2024-07-046</u>) with an Approved Budget of Contract (ABC) Two Hundred Twenty Thousand Nine Hundred Eighty Pesos Only (Php220,980.00) was received by R07-BAC Secretariat on 16 July 2024.

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2024-07-R558 dated 24 July 2024, this procurement was done through Lease of Venue;

WHEREAS, (RO-7BAC) received quotations from two (2) qualified suppliers namely; 1) Goldberry Suites and Hotel Cebu, and 2) Golden Prince Hotel and Suites and two (2) not available from 1) Eastland Hotel and Residences, and 2) Deped Ecotech Center a government-owned establishment as stipulated in the abstract of the quotation;

WHEREAS, on 31 July 2024, the RO7-BAC conducted an online deliberation through Google Meet and considered the quotation submitted by Golden Prince Hotel and Suites as the Lowest Calculated Quotation (LCQ) was subjected for TWG verification as to some discrepancy of the price quoted;

WHEREAS, based on the verification with TWG Report No. 2024-08VR-017 dated 01 August 2024 the Technical Working Group of PSA RSSO 7 BAC has confirmed that Golden Prince Hotel and Suites agrees to adopt the amount written in words;

Whereas, on 02 August 2024, the Region 7 and Awards Committee (R07-BAC) conducted another a face-to-face deliberation;

Whereas, after further evaluation, the R07-BAC declares Golden Prince Hotel and Suites with the Lowest Calculated and Responsive Quotation (LCRQ):

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Venue with Accommodation and Food (PM snacks, buffet breakfast, buffet lunch, and buffet dinner) during the Second Level Training PLDS Data Processing on 6-8 August 2024 be awarded to **Golden Prince Hotel and Suites.**
