RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (RO7-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF VENUE WITH ACCOMMODATION AND FOOD (AM & PM SNACKS AND
BREAKFAST, LUNCH, AND DINNER) DURING THE SECOND LEVEL TRAINING FOR THE
RETAIL PRICE SURVEY OF SELECTED COMMODITIES FOR THE GENERATION OF
CONSUMER PRICE INDEX AND WHOLESALE PRICE SURVEY OF SELECTED
AGRICULTURAL COMMODITIES ON 9 TO 11 JUNE 2025 BE AWARDED
TO GOLDEN PRINCE HOTEL AND SUITES

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue with Accommodation and Food (AM & PM snacks and breakfast, lunch, and dinner) during the Second Level Training for the Retail Price Survey of Selected Commodities for the Generation of Consumer Price Index and Wholesale Price Survey of Selected Agricultural Commodities on 9 to 11 June 2025;

*Whereas, the Purchase Request (**PR No.0700-2025-05-040**) with an Approved Budget of Contract (ABC) of One Hundred Twenty Thousand Seven Hundred Fifty Pesos Only (Php120,750.00) was received by the Regional Office 7 Bids and Awards Committee (RO7-BAC) on 27 May 2025;*

Whereas, as approved by the Head of the Procuring Entity (HOPE) through RO7-BAC Resolution No. 0700-2025-02-R047A dated 05 February 2025, this procurement was done through Lease of Venue;

Whereas, the RO7-BAC received quotations from three (3) suppliers, namely: 1) Golden Prince Hotel and Suites, 2) One Central Hotel, and 3) Yello Hotel; acknowledged receipt of quotation from one (1) supplier, 1) Azia Suites & Residences; and not available from two (2) suppliers: 1) Goldberry Suites and Hotel Cebu and 2) Deped Ecotech Center, a government-owned establishment, as stipulated in the abstract of quotation;

Whereas, the RO7-BAC considered the quotation submitted by Golden Prince Hotel and Suites as the Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the RO7-BAC declares Golden Prince Hotel and Suites with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, that the members of Regional Office 7 Bids and Awards Committee (RO7-BAC), present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the procurement of Venue with Accommodation and Food (AM & PM snacks and breakfast, lunch, and dinner) during the Second Level Training for the Retail Price Survey of Selected Commodities for the Generation of Consumer Price Index and Wholesale Price Survey of Selected Agricultural Commodities on 9 to 11 June 2025 be awarded to **Golden Prince Hotel and Suites**.
