*Whereas, as approved by the Head of the Procuring Entity (HOPE) through R07-BAC Resolution No. 0700-2025-02-R047A dated 05 February 2025, this procurement was done through Small Value Procurement;*

*Whereas, this procurement was posted on 12 February 2025 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11749812 Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;*

*Whereas, R07-BAC received quotations from two (2) qualified suppliers, namely: 1) Miss Kitchenette and 2.) Golden Roast Chicken Inc.;*

*Whereas, the R07 BAC conducted a deliberation on 19 February 2025 at PSA RSSO VII;*

*Whereas, during the opening of bids, the R07-BAC considered the quotation submitted by Golden Roast Chicken Inc. as the Lowest Calculated Quotation (LCQ);*

*Whereas, after evaluation, the R07-BAC declares Golden Roast Chicken, Inc. with the Lowest Calculated and Responsive Quotation (LCRQ);*




