**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF LEASE OF VENUE WITH ACCOMMODATION AND FOOD (AM & PM SNACKS, BUFFET BREAKFAST, BUFFET LUNCH, AND BUFFET DINNER) DURING THE THIRD LEVEL TRAINING ON 2024 ANNUAL SURVEY OF PHILIPPINE BUSINESS AND INDUSTRY (ASPBI) AND 2024 SURVEY OF INFORMATION AND COMMUNICATIONS TECHNOLOGY (SICT) DATA PROCESSING ON 26-30 MAY 2025 BE AWARDED TO GOLDEN PRINCE HOTEL & SUITES**

**Whereas**, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Lease of Venue with Accommodation and Food (AM & PM snacks, buffet breakfast, buffet lunch, and buffet dinner) during the Third Level Training on 2024 Annual Survey of Philippine Business and Industry (ASPBI) and 2024 Survey of Information and Communications Technology (SICT) Data Processing on 26-30 May 2025;

**Whereas**, the Purchase Request (**PR # 0722-2025-05-055**) with an Approved Budget of Contract (ABC) of Eighty-Five Thousand Five Hundred Pesos Only (Php 85,500.00) was received by R07-BAC Secretariat on 13 May 2025;

**Whereas**, as approved by HOPE thru ROBAC Resolution No. 0700-2025-05-R237 dated 21 May 2025, this procurement was done through Lease of Venue;

**Whereas**, the RO 7-BAC received quotations from three (3) qualified suppliers, namely: **1) DepEd Ecotech Center 2) Cebu Business Hotel** and **3) Golden Prince Hotel & Suites** of which two (2) establishments submitted a responsive quotation, while the remaining one (1) submitted acknowledged quotation only, as reflected in the Abstract of Quotation;

**Whereas**, on **21 May 2025**, RO 7-BAC conducted a regular deliberation via teleconferencing through Google Meet of the RO7-BAC;


**Whereas**, during its deliberations, the RO 7-BAC evaluated the quotation submitted by **Cebu Business Hotel** and initially identified it as the **Lowest Calculated Quotation (LCQ)**. However, upon further review, the RO 7-BAC found Cebu Business Hotel to be non-compliant with the technical specifications outlined in the Procurement Request. Accordingly, the RO 7-BAC resolved to consider the next **Lowest Calculated Quotation (LCQ)**, which was submitted by **Golden Prince Hotel & Suites**;

**Whereas**, upon thorough evaluation, the Region 7 Bids and Awards Committee (RO 7-BAC) determined that the quotation submitted by **Golden Prince Hotel & Suites** the **Lowest Calculated and Responsive Quotation (LCRQ)**, having fully complied with the technical specifications set forth in the Procurement Request;

**Now, THEREFORE**, be it resolved, as it is hereby resolved, that the members of RO 7-BAC present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the Procurement of Lease of Venue with Accommodation and Food (AM & PM snacks, buffet breakfast, buffet lunch, and buffet dinner) during the Third Level Training on 2024 Annual Survey of Philippine Business and Industry (ASPBI) and 2024 Survey of Information and Communications Technology (SICT) Data Processing on 26-30 May 2025, be awarded to **Golden Prince Hotel & Suites**;
