**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE**  
**(R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY**  
**(HOPE) THAT THE PROCUREMENT OF GREEN FIRE EXTINGUISHER**  
**9 KILOGRAMS BE AWARDED TO PANGILINAN INDUSTRIAL SUPPLY OPC.**

*Whereas, the Philippine Statistics Authority (PSA)-Regional Statistical Services Office 7 needs to procure green fire extinguisher 9 kilograms:*

*Whereas, the Purchase Request (PR No. 0700-2025-03-028) with an Approved Budget of Contract (ABC) of **Ninety-Thousand Pesos Only (Php90,000.00)** was received by Regional Office 7 Bids and Awards Committee (R07-BAC) Secretariat on 21 March 2025.*

*Whereas, as approved by Head of the Procuring Entity (HOPE) through R07-BAC Resolution No. 0700-2025-03-R128 dated 26 March 2025, this procurement was done through Agency to Agency.*

*Whereas, upon verification in Procurement Service-Department of Budget And Management (PS-DBM), there's no available stock for fire extinguisher and copy of the Certificate of Non – Availability of Stocks (CNAS) is hereto attached marked as “**Annex A**” which forms the integral part hereof;*

*Whereas, this procurement was posted on 29 March 2025 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11929613, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;*

*Whereas, R07-BAC received quotations from five (5) qualified suppliers, namely: 1) SDSM Trading, 2) RCP Manufacturing Company Inc. 3.) Kapper Industries Corporation, 4.) Pangilinan Industrial Supply OPC and 5.) Flamepro Fire Protection Product Trading;*

*Whereas, the R07-BAC with the presence of the member of the Technical Working Group (TWG) conducted a deliberation on 10 April 2025;*

*Whereas, during the opening of bids, R07-BAC considered the quotation submitted by Kapper Industries Corporation as the Lowest Calculated Quotation (LCQ) subject for TWG verification being a first -time supplier and its non-submission of the documentary requirements specifically Philgeps Registration and 2025 Mayor's Permit;*

*Whereas, a verification was conducted through an ocular inspection, and the result was presented by the TWG to the R07-BAC on 30 April 2025;*

*Whereas, Kapper Industries Corporation found to be non -complaint as per the TWG Evaluation Report No. TWG 2025-04VR-009 Report marked as “**Annex B**” and forms an integral part hereof;*

**Whereas**, the R07-BAC proceeded with the next-in-rank Lowest Calculated Quotation (LCQ), Pangilinan Industrial Supply OPC, which is subject to TWG verification as this is its first engagement with PSA RSSO VII and to verify the total amount of the Bid Quotation stated in the Request for Quotation (RFQ) if this refers to the unit price per piece;

**Whereas** the Technical Working Group (TWG) conducted a verification through an ocular inspection, the results of which were presented to the R07-BAC on 07 May 2025, as detailed in the TWG Evaluation Report No. TWG 2025-05VR-010 attached hereto as "Annex C" and made an integral part hereof;

**Whereas**, after further evaluation, the R07-BAC declares Pangilinan Industrial Supply OPC with the Lowest Calculated and Responsive Quotation (LCRQ);

**Now, THEREFORE**, be resolved as it is hereby resolved that the members of the Regional Office 7 Bids and Awards Committee (R07-BAC) present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the procurement of Green Fire Extinguisher 9 Kilograms be awarded to Pangilinan Industrial Supply OPC.


