RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF REPAIR AND REPLACEMENT OF PARTS AND MATERIALS
OF PSA RSSO 7 SERVICE VEHICLE BE AWARDED TO TRANS-MASTER
ENTERPRISES AND SERVICE SHOP.

Whereas, the Philippine Statistics Authority (PSA)-Regional Statistical Services Office 7 needs to procure Repair and Replacement of Parts and Materials of PSA-RSSO 7 Service Vehicle;

*Whereas, the Purchase Request (PR No. 0700-2024-07-044) with an Approved Budget of Contract (ABC) **SIXTY- THOUSAND TWO HUNDRED SIXTY-FIVE PESOS ONLY** (Php60,265.00) was received by R07-BAC Secretariat on 10 July 2024;*

Whereas, as approved by HOPE thru ROBAC Resolution No. 0700-2024-07-R532 dated 10 JULY 2024, this procurement was done through Small Value Procurement;

Whereas, this procurement was posted on 11 July 2024 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11040328, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous;

Whereas, (RO-7BAC) received quotations from two (2) qualified suppliers namely; 1.)Trans-Master Enterprises and Service Shop,2.)Easy-Fix Professional Detailing & Car Services and Three (3) received only namely 1.) SD Autoworld,2.) Speed Master and 3.) Tri-J Marketing;

Whereas, the Region 7 Bids and Awards Committee (R07-BAC) with the presence of the members of the Technical Working Group (TWG) conducted a deliberation on 17 July 2024 via google meet;

Whereas, during the opening of bids, Region 7 Bids and Awards Committee (R07-BAC) considered the quotations submitted by Trans-Master Enterprises and Service Shop as the Lowest Calculated Quotations (LCQ) subject to TWG verification as to compliance on the technical specifications and on the required documentary requirements;

Whereas, a verification was conducted through Phone Call and Onsite Visit and the result was presented by the TWG to the R07-BAC on 02 August 2024 through face-to-face deliberation at PSA RSSO-7 that Trans-Master Enterprises and Service Shop is responsive and can comply on the laid technical specifications and documentary requirements of the procurement;



Whereas, after further evaluation, the R07-BAC declares Trans-Master Enterprises and Service Shop with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Repair and Replacement of Parts and Materials of PSA-RSSO 7 Service Vehicle be awarded to Trans-Master Enterprises and Service Shop.


