RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT
THE PROCUREMENT OF VENUE INCLUDING ACCOMMODATION WITH
FOOD DURING 2022 NATIONAL DEMOGRAPHIC & HEALTH SURVEY
REGIONAL DISSEMINATION FORUM BE AWARDED TO GOLDEN PRINCE
HOTEL AND SUITES

WHEREAS, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure a Venue including Accommodation with Food during 2022 National Demographic & Health Survey Regional Dissemination Forum on 13 July 2023;

WHEREAS an approved Purchase Request with **PR No. 0700-2023-06-054** was received by the R07-BAC secretariat;

WHEREAS the Approved Budget for the Contract (ABC) for the said procurement is **SEVENTY-TWO THOUSAND TWO HUNDRED PESOS ONLY (72,200.00)**

WHEREAS this procurement was done through an Alternative Method of Procurement- Lease of Venue;

WHEREAS, this procurement was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website and Philippine Statistics Authority (PSA) website with reference number 989055;

WHEREAS, Request for Quotations (RFQs)/Bid Forms were sent to PhilGEPS registered establishments;

WHEREAS, the Region 7 Bids and Awards Committee (R07-BAC) received three (3) qualified quotations from Mezzo Hotel, Golden Prince Hotel & Suites, Eastland Hotel & Residences and was acknowledged by Bai Hotel and received a bid form from DepEd Ecotech Center- a government-owned establishment, which is not available as enumerated in the abstract of quotation;

WHEREAS, Region 7 Bids and Awards Committee (R07-BAC) with the presence of the TWG members conducted a deliberation on **06 July 2023 at Cebu Cordova Home Village**;

WHEREAS, during the deliberation the R07 BAC considered the quotation submitted by Eastland Hotel and Residences as the Lowest Calculated Quotation (LCQ) subject to TWG verification on the internet speed, function room requirement on no pillars/columns blocking the stage, parking space, LED display and venue capacity;

WHEREAS, the TWG conducted the verification through phone call to the hotel's Sales Account Executive wherein she confirmed that the venue could accommodate up to 100 persons, they can provide up to 100 mbps internet speed, but the offered venue has pillars/columns blocking the stage. With regards to the LED display requirement, they will outsource/ rent from other supplier, as to the parking space they can only accommodate up to 5 vehicles they cannot provide parking space if there are vehicles from other agencies/organization/participants in excess of five slots;

WHEREAS, based on the verification and laid technical specifications the TWG ascertained that Eastland Hotel & Residences is not responsive and cannot comply with all the technical specifications;

WHEREAS, Region 7 Bids and Awards Committee (R07-BAC) with the presence of the TWG members conducted another deliberation on **07 July 2023 at Cebu Cordova Home Village**;

WHEREAS, based on the TWG verification report and after further evaluation, Eastland Hotel & Residences is not responsive and cannot comply with all the technical specifications,

WHEREAS, the R07-BAC considered the next Lowest Calculated Quotation (LCQ), which is Golden Prince Hotel & Suites;

WHEREAS, after further evaluation, the R07-BAC declared the quotation of Golden Prince Hotel and Suites as the Lowest Calculated and Responsive Quotation (LCRQ);




