

11. Payment of rental fee will be made after receipt claim/invoice from the lessor.

The PSA NCR shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
