WHEREAS, Nueva Ecija Philippine Statistical Office (PSO) requires the Procurement of Food, Venue, and Accommodation for the Conduct of July 2025 Labor Force Survey (LFS) and 2025 Family Income and Expenditure Survey (FIES) Visit 1 Third Level Training;

WHEREAS, **PR-2025-05-0349-141** is included in the 2025 Approved Annual Procurement Plan with line number L-106;

WHEREAS, PSA-RO3-BAC adopted **Negotiated Procurement – Lease of Real Property and Venue** as the Mode of Procurement;

WHEREAS, PSO Nueva Ecija requested the suppliers ACROPOLIS NORTH WATERCAMP AND COUNTRY CLUB INC., RDT HOTELS AND RESORT INC. and CASA JEDLIANA HOTEL AND RESORT to submit a quotation for Procurement of Food, Venue, and Accommodation for the Conduct of July 2025 Labor Force Survey (LFS) and 2025 Family Income and Expenditure Survey (FIES) Visit 1 Third Level Training based on **RFQ-049-021**;

WHEREAS, on or before 22 May 2025, ACROPOLIS NORTH WATERCAMP AND COUNTRY CLUB INC., RDT HOTELS AND RESORT INC. and CASA JEDLIANA HOTEL AND RESORT submitted a copy of their quotation;

WHEREAS, during the opening and evaluation of quotations on **23 May 2025** ACROPOLIS NORTH WATERCAMP AND COUNTRY CLUB INC., RDT HOTELS AND RESORT INC. and CASA JEDLIANA HOTEL AND RESORT were all rated **"PASSED"** and declared Eligible and Technically Compliant;
