WHEREAS, Nueva Ecija Provincial Statistical Office (PSO) requires the Procurement of food, venue, and accommodation for the conduct of the Third Level Training on the Conduct of the 2025 Updating of List of Agricultural Farm Operators and Inland Fishing Households, and 2025 Listing of Marine Fish Landing Centers (ULAFO-LMFLC) ;

WHEREAS, **PR-2025-07-0349-219** is included in the Approved 2025 Supplemental Annual Procurement Plan No. 21 with line number S-111;

WHEREAS, PSA-RO3-BAC adopted **Negotiated Procurement – Lease of Real Property and Venue** as the Mode of Procurement;

WHEREAS, PSO Nueva Ecija requested the suppliers CASA JEDLIANA CORPORATION, FIRST KINGSTON LEISURE AND SERVICES CORPORATION and ACROPOLIS NORTH WATER CAMP AND COUNTRY CLUB, INCORPORATION to submit a quotation for Procurement of food, venue, and accommodation for the conduct of the Third Level Training on the Conduct of the 2025 Updating of List of Agricultural Farm Operators and Inland Fishing Households, and 2025 Listing of Marine Fish Landing Centers (ULAFO-LMFLC) based on **RFQ-049-029**;

WHEREAS, on or before 16 July 2025, CASA JEDLIANA CORPORATION, FIRST KINGSTON LEISURE AND SERVICES CORPORATION and ACROPOLIS NORTH WATER CAMP AND COUNTRY CLUB, INCORPORATION submitted a copy of their quotation;

WHEREAS, during the Virtual opening and evaluation of quotations on **24 July 2025** CASA JEDLIANA CORPORATION, FIRST KINGSTON LEISURE AND SERVICES CORPORATION and ACROPOLIS NORTH WATER CAMP AND COUNTRY CLUB, INCORPORATION were all rated "**PASSED**" and declared Eligible and Technically Compliant.






