RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF LOT 2: REPRODUCTION OF MANUALS FOR THE CONDUCT OF THIRD
LEVEL TRAINING ON 2024 ANNUAL SURVEY OF PHILIPPINE BUSINESS AND INDUSTRY
AND 2024 SURVEY OF INFORMATION AND COMMUNICATIONS TECHNOLOGY (2024
APSBIS/ICT) OF PSA CEBU BE AWARDED TO L.G. COPY EXPRESS.

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 under Republic Act No. 10625, otherwise known as the Philippine Statistical Act of 2013 is mandated to conduct periodic censuses on population, housing, agriculture, fisheries, business, industry, and other sectors of the economy;

Whereas, the Philippine Statistics Authority- Cebu Provincial Statistical Office (PSA Cebu PSO), Cebu City, Cebu is in need of printing services for reproduction of manuals for the 2024 Annual Survey of Philippine Business and Industry and 2024 Survey of Information and Communications Technology;

*Whereas, the Purchase Request (**PR No.0722-2025-03-032**) with an Approved Budget of Contract (ABC) Twenty-Seven Thousand One Hundred Fifty Pesos Only (Php27,150.00) was received by R07-BAC Secretariat on 20 March 2025;*

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2025-03-R132B dated 26 March 2025, this procurement was done through Small Value Procurement;

Whereas, this procurement was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, Philippine Statistics Authority (PSA) website, and in a conspicuous place in compliance to the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 otherwise known as the Government Procurement Act on 28 March 2025 with reference no. 11925830;

***WHEREAS,** (RO-7BAC) received quotations from three (3) qualified suppliers namely; **1) L.G. Copy Express; 2) Mybañez Printing Press;** and **3) DMC Busa Printshoppe** as stipulated in the abstract of the quotation;*

*Whereas, on **02 April 2025**, the R07-BAC conducted a deliberation through **video teleconferencing** and considered the quotation submitted by **MYBAÑEZ PRINTING PRESS** as the Lowest Calculated Quotation (LCQ);*

*Whereas, upon checking on the bid and documents submitted by **MYBAÑEZ PRINTING PRESS**, R07-BAC found out that in lieu of the Mayor's Permit, they only submitted the Official Receipt on its renewal;*

*Whereas, upon evaluation and verification, R07-BAC with the assistance of the Technical Working Group (TWG) declared **MYBAÑEZ PRINTING PRESS** as unresponsive and disqualified and consider the next Lowest Calculated and Responsive (LCQ), **L.G. COPY EXPRESS;***

*Whereas, upon careful evaluation, post qualification, and verification, R07-BAC with the assistance of the Technical Working Group (TWG) **L.G. COPY EXPRESS** as the Lowest Calculated and Responsive Quotation (LCRQ),*

Now, THEREFORE,** be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Reproduction of Manuals for the 2024 Annual Survey of Philippine Business and Industry and 2024 Survey of Information and Communications Technology of PSA Cebu be awarded to **L.G. COPY EXPRESS.
