RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF CATERING SERVICES (AM SNACKS AND BUFFET LUNCH) FOR THE 2025 NATIONAL WOMEN'S MONTH CELEBRATION ON 14 MARCH 2025 AND 28 MARCH 2025 BE AWARDED TO MATETH CATERING SERVICES AND THE ACTIVITY FOR 03 MARCH 2025 WAS CANCELLED.

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Catering Services (AM Snacks and Buffet Lunch) for the 2025 National Women's Month Celebration on 14 March 2025 and 28 March 2025;

Whereas, the Purchase Request (PR # 0722-2025-02-023) with an Approved Budget of Contract (ABC) of Fifty-One Thousand Two Hundred Pesos Only (Php 51,200.00) was received by R07-BAC Secretariat on 17 February 2025;

Whereas, as approved by HOPE thru ROBAC Resolution No. 0700-2025-02-R078A dated 21 February 2025, this procurement was done through Small Value Procurement;

Whereas, the RO 7-BAC received quotations from four (4) qualified suppliers, namely: 1) Mateth Catering Services 2) Markguin's Lutong Bahay 3) Brick Brew Café, and 4) DepEd Ecotech; of which only one (1) establishment submitted a responsive quotation, while the remaining three (3) submitted acknowledged quotations only, as reflected in the Abstract of Quotation;

Whereas, on 08 March 2025, the RO 7-BAC conducted a special deliberation via Messenger through the Official Group Chat of the RO7-BAC:

Whereas, during the deliberation RO 7-BAC evaluated the quotation submitted by Mateth Catering Services and identified it as the Lowest Calculated Quotation (LCQ). It was also noted that the activity originally scheduled for 03 March 2025 was cancelled, as it coincided with the date of the deliberation for the award. Consequently, there would not have been sufficient time for the supplier to deliver its services. This concern was likewise confirmed by the designated focal person;

Whereas, upon careful evaluation, the Region 7 Bids and Awards Committee (RO 7-BAC) determined that the quotation submitted by Mateth Catering Services was the Lowest Calculated and Responsive Quotation (LCRQ); and further noted that the activity scheduled for 03 March 2025 was cancelled;

Now, THEREFORE, be it resolved, as it is hereby resolved, that the members of RO 7-BAC present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the Procurement of Catering Services (AM Snacks and Buffet Lunch) for the 2025 National Women's Month Celebration, scheduled on 14 March 2025 and 28 March 2025, be awarded to Mateth Catering Services, and that the activity originally scheduled for 03 March 2025 is considered cancelled.
