**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT FOR THE
PROCUREMENT SUPPLY AND DELIVERY OF OPERATIONAL SUPPLIES AND EQUIPMENT
FOR THE PHILIPPINE IDENTIFICATION SYSTEM STEP 2 REGISTRATION FOR THE
MONTHS OF SEPTEMBER TO DECEMBER 2021(REPOSTING) FOR THOSE ITEMS
DECLARED AS DAILURE DURING THE FIRST BIDDING BE AWARDED TO MCB INK
TRADING (LOTS A-CONSUMABLES) AND TRIMAX COMPUTER SUPPLIES AND GENERAL
MERCHANDISE (LOT B- ELECTRICAL EQUIPMENT AND COMPONENTS AND SUPPLIES)**

Whereas, the Philippine Statistics Authority continues to conduct the Step 2 Registration for the Philippine Identification System (PhilSys) for 2021;

Whereas, there's a need to procure Supplies and Equipment for the Philippine Identification System Step 2 Registration for the months of September to December 2021;

Whereas, this procurement was done through Competitive Bidding with **ONE MILLION SIX HUNDRED FIFTY-TWO THOUSAND AND FIVE HUNDRED PESOS ONLY (PhP1,652,500.00)** as the total sum with a corresponding Approved Budget for the Contract (ABC) per lot as follows:

Whereas, this procurement was posted at the Philippine Government Electronic Procurement System (PhilGEPS) website, Philippine Statistics Authority (PSA) website, and in three (3) conspicuous places in compliance to the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 otherwise known as the Government Procurement Act on **28 September 2021** with reference no. **8034622**;

Whereas, the Pre-Bid Conference was conducted on 6 October 2021 at PSA RSSO VII, Gaisano Capital South Bldg., Colon St., Cebu City through video conferencing via zoom meeting and attended by the following:

4. Prospective Bidders (Maxprint Enterprises, RM Industrial Sales, Visayan Educational Supplies, MCB Ink Trading, and Trimax Computer Supplies and General Merchandise)

Whereas, during the posting period, Supplemental Bid Bulletin was being issued relative to the amendments on the technical specifications, and clarifications on the items discussed during the pre-bid conference per **R07-BAC Resolution No. 2021-10-008-PB**;

Whereas, the Opening of Bids was conducted on 18 October 2021 at PSA RSSO VII, Gaisano Capital South Bldg., Colon St., Cebu City and through video conferencing via zoom meeting and attended by the following:

3. Technical Working (Group)
4. R07-BAC Secretariats
5. Two Bidders as follows:

Whereas, three (3) observers were invited to the opening of bids, however, one (1) observer attended during the bid opening;

Whereas, the sequence in the opening of the bids was according to the order in the acknowledgement receipt of Bids as received by the R07-BAC Secretariat; in the acknowledgement receipt of Bids

Whereas, the R07-BAC open first the Technical Documents or the first component envelope for all submitted bids according to the order in the acknowledgement receipt of Bids followed by the opening of the second component envelope (Financial Documents) for all eligible and technically complying bidder/s;

Whereas, the first bid that was opened is from MCB Ink Trading which was declared "PASS" after checking all submitted documents against the checklist of required documents for both Technical and Financial Components;

Whereas, the second bid that was opened is from Trimax Computer Supplies and General Merchandise which was declared "PASS" after checking all submitted documents against the checklist of required documents for both Technical and Financial Components;

Whereas, all bidders were declared as qualified bidders and bids submitted shall be considered for Detailed Evaluation and Comparison of Bids;

Whereas, a detailed evaluation and comparison of bids was conducted on the 22 October 2021 and considered the following as the Single Calculated Bidder (SCB) or Lowest Calculated Bidder (LCB):

Whereas, the final post-qualification was conducted on 11 November 2021 and the additional documentary requirements were checked, verified and validated and found the above bidders to have complied and passed all the criteria;

Whereas, after thorough deliberation by the R07-BAC based on the documents submitted and post-qualification, the following were declared as the Single Calculated Responsive Bidder (SCRB) or Lowest Calculated Responsive Bidder (LCRB)



Now, **THEREFORE**, be it resolved as it is hereby resolved that majority of the members of the Region 7 Bids and Awards Committee (R07-BAC) recommend to the Head of the Procuring Entity (HOPE) that the Procurement for the Supply and Delivery of Operational Supplies and Equipment for The Philippine Identification System Step 2 Registration for The Months Of September to December 2021 (Reposting) for the items declared as failure during the first bidding be Awarded to MCB Ink Trading (Lot A-Consumables), and Trimax Computer Supplies and General Merchandise (Lot B -Electrical Equipment and Components and Supplies).




