RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF PRINTING OF MANUAL & QUESTIONNAIRE FOR THE 3RD LEVEL TRAINING JULY 2025 LABOR FORCE SURVEY (LFS)/2025 FAMILY INCOME AND EXPENDITURES SURVEY (FIES) VISIT 1 ON 30 JUNE - 6 JULY 2025 FOR PSA CEBU BE AWARDED TO MYBAÑEZ PRINTING PRESS.

Whereas, Philippine Statistics Authority (PSA) – Cebu Provincial Statistical Office needs to procure Printing of Manual & Questionnaire for the 3rd Level Training July 2025 Labor Force Survey (LFS)/2025 Family Income and Expenditures Survey (FIES) Visit 1 on 30 June - 6 July 2025 for PSA Cebu;

Whereas, the Purchase Request (**PR No. 0722-2025-05-059**) with an Approved Budget for the Contract (ABC) of One Hundred Fifty-five Thousand Five Hundred Fifty-Two Pesos Only (Php 155,552.00) and was received by R07-BAC Secretariat on 20 May 2025;

Whereas, as approved by HOPE thru ROBAC Resolution No. 0700-2025-06-R289 dated 11 June 2025, this procurement was done through Small Value Procurement;

Whereas, this procurement was posted at the Philippine Government Electronic Procurement (PhilGEPS) website, Philippine Statistics Authority (PSA) website, and at the PSA Cebu PSO Transparency Bulletin (conspicuous space of the office) in compliance with the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 otherwise known as the Government Procurement Act on 12 June 2025 with reference no. 12123655;

Whereas, (RO-7BAC) received quotations from four (4) qualified suppliers namely; **1) Mybañez Printing Press, 2.) L.G Copy Express, 3.) Double DD Risocopy and Bookbinding Services, and 4.) DMC Busa Printshoppe**, in which two (2) establishments have submitted a responsive quotation and two (2) establishments have received only, as stipulated in the abstract of the quotation;

Whereas, on **18 June 2025**, the R07-BAC conducted a deliberation through virtual teleconferencing via Google meet and considered the quotation submitted by **Mybañez Printing Press** as the Lowest Calculated Quotation (LCQ);

Whereas, upon careful evaluation, the Region 7 Bids and Awards Committee (R07-BAC) considered the quotation submitted by **Mybañez Printing Press** as the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Printing of Manual & Questionnaire for the 3rd Level Training July 2025 Labor Force Survey (LFS)/2025 Family Income and Expenditures Survey (FIES) Visit 1 on 30 June - 6 July 2025 be awarded to **Mybañez Printing Press**.
