A Resolution on Rescheduled Conduct of 2017 Listing of Farm Households to September 2017

RESOLUTION NO. 2

Series of 2017

WHEREAS, the Philippine Statistics Authority (PSA) is the central statistical authority of the Philippine government. It plans, develops, prescribes, disseminates and enforces policies, rules and regulations, and coordinates government-wide programs governing the production of official statistics, general-purpose statistics and civil registration services.

WHEREAS, the office is also primarily responsible for the conduct of all national censuses and surveys, sectoral statistics, consolidation of selected administrative recording systems and compilation of national accounts.

WHEREAS, come July of this year, the office shall be conducting the 2017 Listing of Farm Households (LFH). This activity aims to refresh and update the sampling frame for agricultural-based surveys. This listing operation requires the use of android tablets. Enumerators and team supervisors will also be provided with polo shirts. The total amount for the procurement of these items thereby necessitates the office to conduct a public bidding.

WHEREAS, it is for this reason that the **Philippine Statistics Authority-Regional Statistical Services Office XI (PSA-RSSO XI)** invited prospective bidders by posting the Invitation to Bid No. 2017-01 for the Procurement of Android Tablets and Polo Shirts for the Conduct of 2017 LFH in the PhilGEPS website, PSA website and on a conspicuous place within the premises of the PSA-RSSO XI continuously from May 15-22, 2017;

WHEREAS, the Medium-term Information & Communications Technology Harmonization Initiative (MITHI) is an e-Government and ICT support initiative that aims to harmonize and ensure interoperability among ICT-related resources, programs, and projects across the government;

WHEREAS, the scope of the MITHI states that all ICT-related resources, programs, and projects shall be a part of the harmonization effort of MITHI, and shall be understood in their conventional meaning, which shall be for the Participating Agencies to ascribe, and for the Steering Committee to decide

WHEREAS, as to program/project, both on-going/existing and proposed/new ICT programs and projects will be processed through MITHI... regardless of fund source shall be part of the harmonization effort;

WHEREAS, through MITHI, the Government will be able to (1) More objectively identify which ICT programs and projects to prioritize, (2) Harmonize ICT procurement and usage, (3) Take better advantage of economies of scale and promote synergies of interoperability, and (4) Ensure that ICT programs and projects are aligned with the 5 Key Result Areas (KRAs) of the government, to wit: Good Governance, Peace and Rule of Law, Poverty Reduction, Inclusive Growth, and Integrity of Environment;

WHEREAS, the PSA Central Office advised the PSA-RSSO XI to postpone this procurement opportunity while waiting for the approval of the amended PSA's Information Systems Strategic Plan (ISSP) by the MITHI;

WHEREAS, Office Memorandum with Reference No. 17NCS00-094 was issued with a subject "Rescheduled Conduct of 2017 Listing of Farm Households to September 2017";

NOW THEREFORE, We, the Members of the RBAC XI, hereby **RESOLVE** as it is hereby **RESOLVED**;

- 1.) To reschedule the conduct of 2017 LFH to September 2017 and to postpone the procurement of android tablets and polo shirts to the following schedule:






