**RESOLUTION OF PHILIPPINE STATISTICS AUTHORITY REGION 7 BIDS AND AWARDS COMMITTEE (PSA R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT AND DELIVERY OF DESKTOP COMPUTERS FOR THE 2023 INTEGRATED PROCESSING OF MAPS FROM VARIOUS ACTIVITIES BE AWARDED TO JOEBZ COMPUTER SALES AND SERVICES**

*Whereas, the Philippine Statistics Authority Regional Statistical Services Office No. 7 and the Provincial Offices of Bohol, Cebu, Negros Oriental, and Siquijor are in need of Desktop Computers for the 2023 Integrated Processing of Maps from Various Activities;*

*Whereas, this procurement was done through Competitive Bidding with Eight Million Four Hundred Forty-Eight Thousand Pesos Only (PHP8,448,000.00) as the total Approved Budget for the Contract (ABC) with a corresponding ABC per lot as follows;*

**Whereas**, the opening of bids was conducted on 24 May 2023 at PSA RSSO VII, Gaisano Capital South Bldg., Colon St., Cebu City through video conferencing via Zoom meeting and attended by the following:

**Whereas**, the submitted bidding documents comprise the first component envelope (Technical Component) and the second component envelope (Financial Component);

**Whereas**, the BAC opened first the Technical Component or the first component envelope for all submitted bids according to the order mentioned above;



**Whereas**, the BAC checked all submitted documents of each bidder for the first component envelope against the checklist of required documents to ascertain if they are all present, using a non-discretionary "pass or fail" criterion;

**Whereas**, the bid submitted by Masangkay Computer Center, Joneco Tech Marketing Corp., Terabit Computer Systems Corp., and Joebz Computer Sales and Services for the requirements under the Technical Documents was complete and patently sufficient;

**Whereas**, Masangkay Computer Center, Joneco Tech Marketing Corp., Terabit Computer Systems Corp., and Joebz Computer Sales and Services were rated "pass" and were declared as technically complying bidders after the opening of the first envelope;

**Whereas**, the second envelope or the Financial Documents were immediately opened after the opening of the first envelope;

**Whereas**, Masangkay Computer Center, Joneco Tech Marketing Corp., Terabit Computer Systems Corp., and Joebz Computer Sales and Services was declared as qualified bidder after checking the submitted financial documents;

**Whereas**, it was moved and seconded that all qualified bids shall be immediately considered for Bid evaluation and Bid comparison;

**Whereas**, the Detailed Evaluation and Comparison of Bids was conducted on 26 May 2023;






