RESOLUTION OF PHILIPPINE STATISTICS AUTHORITY REGION 7 BIDS AND AWARDS COMMITTEE (PSA R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURRING ENTITY (HOPE) TO AWARD THE PROCUREMENT AND DELIVERY OF DESKTOP COMPUTERS AND OTHER REQUIREMENTS FOR THE 2024 CENSUS OF POPULATION AND COMMUNITY-BASED MONITORING SYSTEM (2024 POPCEN-CBMS) DATA PROCESSING TO REMAX INTERNATIONAL INC.

Whereas, the Philippine Statistics Authority Regional Statistical Services Office No. 7 and the Provincial Offices of Cebu, and Negros Oriental needs to procure Desktop Computers and other requirements for the 2024 Census of Population and Community-Based Monitoring System (2024 POPCEN-CBMS) Data Processing;

Whereas, this procurement was done through Competitive Bidding with SIX MILLION TWO HUNDRED FORTY-THREE THOUSAND PESOS ONLY (PHP6,243,000.00) as the total Approved Budget for the Contract (ABC) with a corresponding ABC per item as follows;

Whereas, clarifications were raised by the prospective bidder relative to the bidding document during the pre-bid conference;

Whereas, the Region 7-Bids and Awards Committee (R07-BAC) agreed to issue a supplemental bid bulletin on 24 September 2024 relative to the changes in the schedule of bidding activities;

Whereas, the Bids and Awards Committee (BAC) convened on 24 September 2024 and hereby resolved to issue a Supplemental Bid Bulletin for the Amendments and Clarifications of the Bidding Documents and other requirements;

Whereas, a Supplemental Bid Bulletin No PB-2024-09-003 was issued on 24 September 2024 for the amendments and clarifications to the issues raised by prospective bidders during the pre-bid conference;

Whereas, the opening of bids was conducted on 01 October 2024 at PSA RSSO VII, Gaisano Capital South Bldg., Colon St., Cebu City and through video conferencing via Zoom meeting and attended by the following:

Whereas, in response to the posted invitation to bid, the following bidders submitted their bids;

Whereas, the submitted bidding documents comprise the first component envelope (Technical Component) and the second component envelope (Financial Component);

Whereas, the BAC opened first the first component envelope (Technical Component) for all submitted bids according to the order mentioned above;

Whereas, the BAC checked all submitted documents of each bidder for the first component envelope (Technical Component) against the checklist of required documents to ascertain if they are all present, using a non-discretionary "pass or fail" criterion;

Whereas, the bid submitted by Joneco Tech Marketing Corp., Remax International Inc., and Joebz Computers Sales & Services for the requirements under the first component envelope (Technical Component) were complete and patently sufficient;

Whereas, Joneco Tech Marketing Corp., Remax International Inc., and Joebz Computers Sales & Services were rated "pass" and were declared as technically complying bidders after the opening of the first component envelope (Technical Component);

Whereas, the second component envelope (Financial Component) of all technically complying bidders was immediately opened;

Whereas, the bid submitted by Joneco Tech Marketing Corp., Remax International Inc., and Joebz Computers Sales & Services for the requirements under the second component envelope (Financial Component) were complete and patently sufficient;

Whereas, Joneco Tech Marketing Corp., Remax International Inc., and Joebz Computers Sales & Services were rated as "pass" and declared as qualified bidders having complied with the requirements;

Whereas, the PSA Region 7 Bids and Awards Committee (PSA R07-BAC) resolved on 01 October 2024 during the opening of bids that the following bidder is considered as the Lowest/Single Calculated Bidder (L/SCB) as bid for each item;
