## Platinum Membership

Pursuant to Section 8.5.2 of the Revised IRR of RA 9184, all bidders shall upload and maintain in PhilGEPS a current and updated file of the following Class "A" eligibility documents under Sections 23.1(a) and 24.1(a) of the same IRR:

- Business RegistrationCertificate
- Mayor's or Business Permit or its equivalent document
- Tax Clearance
- Philippine Contractors
   Accreditation Board (PCAB)
   license and registration, and
- Audited Financial Statements (AFS)

These documents shall be accompanied by a Sworn Statement stating that the submitted documents are complete and authentic copies of the original, and all statements and information provided are true and correct.
