<p>Clarification on the attachment of sample contract for all its ongoing government and private contracts</p>	<p>The bidder may or may not attach all the supporting documents for all its ongoing government and private contracts including contracts awarded but not yet started. Non-attachment of the said documents will not result in the disqualification of the bidder. However, during the post-qualification, the bidder shall present these documents for validation and verification by the RBAC or its Technical Working Group (TWG).</p>
