




<p>1. Single Largest Completed Contract (SLCC)</p>	<p>Emphasis on the SLCC: paragraph 5.3C, to be read as “in the amount of at least equivalent of 50% of each lot to bid”.</p>
<p>2. Bid Security</p>	<p>Emphasis on paragraph 19. Detailed Evaluation and Comparison of Bids</p> <p>19.2 If the Project allows partial bids, bidders may submit a proposal on any of the lots or items, and evaluation will be undertaken on a per lot or item basis, as the case maybe. In this case, the Bid Security as required by ITB Clause 14 shall be submitted for each lot or item separately.</p>
<p>3. Net Financial Contracting Capacity (NFCC)</p>	<p>Emphasis on the Evaluation of NFCC.</p> <p>NFCC is for all lots to bid.</p>
<p>4. Clarification on the submission of the technical component envelope</p>	<p>For Bidders who intend to Bid for one LOT, several LOTs or all LOTs, each bidder shall</p>

	<p>submit ONE TECHNICAL COMPONENT ENVELOPE for all lots to bid.</p> <p>The technical component envelope should be in three copies, one copy (original) and two copies (copy 1 and copy 2) which are certified true copies of the original document. However, bid security (in any form) shall be separate for each lot to bid.</p>
5. Clarification on the submission of the Conformity with the Technical Specifications?	Under conformity with the Technical Specifications, only check for "complied" on the technical specification of all lots to bid and there is no need to check for "complied" on lots that are not included in the bid.
6. Clarification on the submission of Original duly signed Omnibus Sworn Statement (OSS)	Submission of the Original duly signed Omnibus Sworn Statement (OSS) is per lot
7. Clarification on the quantity of each item	The quantity of each item is found in the bidding documents under Section VII, Technical Specifications.
