RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF VENUE WITH ACCOMMODATION AND FOOD (AM & PM SNACKS, BREAKFAST, LUNCH AND DINNER) DURING THE FIELD VISIT ON BREEDING STOCKS AND ORCHARD DEVELOPMENT TOWARDS THE OVERALL REVISION AND REBASING OF THE PHILIPPINE SYSTEM OF NATIONAL ACCOUNTS ON 04 TO 05 MARCH 2025 IN BOHOL BE AWARDED TO BOHOL DINE AND SIGN INC.

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue with Accommodation and Food (AM & PM snacks, breakfast, lunch and dinner) during the Field Visit on Breeding Stocks and Orchard Development towards the Overall Revision and Rebasing of the Philippine System of National Accounts on 06 to 07 March 2025 in Bohol;

Whereas, the Purchase Request (<u>*PR No.0700-2025-02-016</u>) with an Approved Budget of Contract (ABC) of Nineteen Thousand Nine Hundred Pesos Only (Php19,900.00) was received by the Regional Office 7 Bids and Awards Committee (R07-BAC) on 25 February 2025;*</u>

Whereas, as approved by the Head of the Procuring Entity (HOPE) through RO7-BAC Resolution No. 0700-2025-02-R082 dated 26 February 2025, this procurement was done through Lease of Venue;

Whereas, RO7-BAC received quotations from two (2) suppliers; 1) Bohol Dine and Sign Inc. and 2) Kew Hotel (quotation is above ABC) and one (1) fully booked from Maxi Hotel as stipulated in the abstract of the quotation;

Whereas, during the opening of bids, RO7-BAC considered the quotation submitted by Bohol Dine and Sign Inc. as the Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the RO7-BAC declares Bohol Dine and Sign Inc. with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved that the members of Regional Office 7 Bids and Awards Committee (R07-BAC) present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the procurement of Venue with accommodation and food (AM & PM snacks, breakfast, lunch and dinner) during the Field Visit on Breeding Stocks and Orchard Development towards the Overall Revision and Rebasing of the Philippine System of National Accounts on 04 to 05 March 2025 in Bohol be awarded to **Bohol Dine and Sign, Inc.**
