RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF CUSTOMIZED ITEM FOR THE SECOND LEVEL TRAINING ON 2023 HOUSEHOLD ENERGY CONSUMPTION SURVEY (HECS) BE AWARDED TO ARTEESTIC PRINTSHOPPE

WHEREAS, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Customized Item for The Second Level Training on 2023 Household Energy Consumption Survey (HECS);

WHEREAS, the Purchase Request (**PR No.0700-2024-05-036**) with an Approved Budget of Contract (ABC) **Ninety-Three Thousand Pesos Only (Php 93,000.00)** was received by R07-BAC Secretariat on 04 June 2024.

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2024-06-R359D dated 05 June 2024, this procurement was done through Small Value Procurement;

Whereas, this procurement was posted on 08 June 2024 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.10934142, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;

WHEREAS, (RO-7BAC) received quotations from two (2) suppliers namely; **1) Arteestic Printshoppe, and 2) Stitches and Wear** and three (3) acknowledged receipts from **1) DMC Busa Printshoppe, 2) Megawear, and 3) Cebu Artshoppe** as stipulated in the abstract of the quotation;

WHEREAS, on 14 June 2024, the R07-BAC conducted an online deliberation via Messenger and considered the quotation submitted by **Arteestic Printshoppe** as the Lowest Calculated Quotation;

WHEREAS, upon careful evaluation, the Region 7 Bids and Awards Committee (R07-BAC) considered the quotation submitted by **Arteestic Printshoppe** as the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Customized Item for The Second Level Training on 2023 Household Energy Consumption Survey (HECS) be awarded to **Arteestic Printshoppe**.
