RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF VENUE WITH ACCOMMODATION AND FOOD (AM & PM SNACKS, BUFFET BREAKFAST, BUFFET LUNCH, AND BUFFET DINNER) DURING THE SECOND LEVEL OPERATIONAL TRAINING FOR CROPS PRODUCTION SURVEY ON 27 FEBRUARY TO 1 MARCH 2024 BE AWARDED TO HOLIDAY PLAZA HOTEL

WHEREAS, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 is in need to procure a Venue with Accommodation and Food (AM & PM snacks and buffet breakfast, buffet lunch, and buffet dinner) during the Second Level Operational Training for Crops Production Survey on Selected Industries/ Producer Price Survey on 27-29 February 2024;

WHEREAS, an approved Purchase Request with **PR No. 0700-2024-02-011** was received by the R07-BAC Secretariat;

WHEREAS, this procurement was done by lot;

WHEREAS, the Approved Budget for the Contract (ABC) of the said procurement is **Sixty-five Thousand Seven Hundred Pesos (Php65,700.00)**;

WHEREAS, this procurement was done through an Alternative Method of Procurement – Lease of Venue;

WHEREAS, the bid forms were sent to various suppliers which are registered with PhilGEPS;

WHEREAS, before the closing date of submission, the secretariat received four (4) qualified quotations from **1) Goldberry Suites and Hotel Cebu, 2) Holiday Plaza Hotel, 3) Alpa City Suites, and Golden Prince Hotel and Suites** and six (6) acknowledgment from **Golden Peak Hotel & Suites, Eastland Hotel and Residences, Elizabeth Hotel, One Central Hotel, Yello Hotel and Deped Ecotech Center** -a government-owned establishment as stipulated in the abstract of the quotation;

WHEREAS, the Region 7 Bids and Awards Committee (R07-BAC) with the presence of a member of the Technical Working on Group (TWG) conducted a deliberation via **Google Meet on 23 February 2024**;

WHEREAS, during the deliberation, Region 7 Bids and Awards Committee (R07-BAC) the quotation submitted by Goldberry Suites and Hotel Cebu is considered as the Lowest Calculated Quotation (LCQ) subject for TWG verification as to the provision of Function Room indicated in the Request for Quotation;

WHEREAS, on 24 February 2024, the TWG immediately conducted an ocular visit of the establishment, Goldberry Suites and Hotel Cebu, and interviewed the Establishments Sales Representative, and presented to the TWG that the possible venue of the activity will be a boardroom that can accommodate a maximum of twelve (12) persons and that meals will be served on either the venue or at the ground floor of the hotel;

WHEREAS, based on the verification with TWG Report No. 2024-02VR-005, the Technical Working Group has determined that Goldberry Suites and Hotel Cebu is deemed not responsive and cannot meet the specified technical requirements;

WHEREAS, upon careful evaluation and based on the result of the TWG report, the R07-BAC proceeded to the next Lowest Calculated Quotation (LCQ) which is the Holiday Plaza Hotel, and subject to TWG verification as to the compliance of all the technical requirements;

WHEREAS, on 25 February 2024, the TWG immediately conducted an ocular visit of the establishment, Holiday Plaza Hotel, and interviewed the Sales Representative and presented to the TWG the possible venue of the activity on the second floor and can accommodate a maximum of fifteen (15) persons and the other needed equipment such as projector and projector screen as well as necessary audio equipment will be provided at the venue;

WHEREAS, based on the verification with TWG Report No. 2024-02VR-008 the Technical Working Group has determined that Holiday Plaza Hotel is deemed responsive and can comply with the laid technical specifications of the procurement;

WHEREAS, upon careful evaluation and based on the result of the TWG report, the R07-BAC proceed to the next Lowest Calculated Quotation (LCQ) which is the Holiday Plaza Hotel and at the same time Lowest Calculated and Responsive Quotation (LCRQ), having complied all the technical requirements;

NOW, THEREFORE, be it resolved as it is hereby resolved that the members of the Region 7 Bids and Awards Committee (R07-BAC) present during the deliberation unanimously recommend to the Head of the Procuring Entity (HoPE) that the procurement of Venue with Accommodation and Food (AM & PM snacks and buffet breakfast, lunch, and dinner) during the Second Level Operational Training for Crops Production Survey (CrPS) on 27 February to 1 March 2024 be awarded to **Holiday Plaza Hotel**.
