**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF CERTIFICATE HOLDER FOR THE CONDUCT OF THE REGIONAL DATA
FESTIVAL FOR VISAYAS CLUSTER BE AWARDED TO ARTEESTIC PRINTSHOPPE.**

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Certificate Holder for the conduct of the Regional Data Festival for Visayas Cluster;

Whereas, the Purchase Request (**PR No.0700-2024-09-071**) with an Approved Budget of Contract (ABC) **Seven Thousand Five Hundred Pesos Only (Php7,500.00)** was received by R07-BAC Secretariat on 08 October 2024;

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2024-10-R756 dated 09 October 2024, this procurement was done through Small Value Procurement;

Whereas, this procurement was posted on 12 October 2024 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11354724, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;

Whereas, RO-7BAC received quotations from two (2) suppliers namely; **1.) Arteestic Printshoppe and 2.) L.G Copy Express** and one (1) received only from **Awards Central Philippines Inc**, as stipulated in the abstract of the quotation;

Whereas, during the opening of bids, RO-7 BAC considered the quotation submitted by **Arteestic Printshoppe** as the Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the RO-7 BAC declares **Arteestic Printshoppe** with the Lowest Calculated and Responsive Quotation (LCRQ);


Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Certificate Holder for the conduct of the Regional Data Festival for Visayas Cluster be awarded to **Arteestic Printshoppe**.
