**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF TOKEN DURING THE CREATIVE INDUSTRIES SATELLITE ACCOUNTS
PHASE 2 FOCUS GROUP DISCUSSIONS (FGDS) ON CREATIVE ECONOMY OF VISAYAS
CLUSTER ON 26 NOVEMBER 2024 BE AWARDED TO ARTEESTIC PRINTSHOPPE**

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Token during the Creative Industries Satellite Accounts Phase 2 Focus Group Discussions (FGDS) on Creative Economy of Visayas Cluster on 26 November 2024;

*Whereas, the Purchase Request (**PR No.0700-2024-11-079**) with an Approved Budget of Contract (ABC) of Thirty-Two Thousand Seven Hundred Sixty Pesos Only (Php32,760.00) was received by R07-BAC Secretariat on 11 November 2024;*

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2024-11-R854 dated 12 November 2024, this procurement was done through Small Value Procurement;

Whereas, this procurement was posted on 15 November 2024 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11482614, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;

Whereas, RO-7BAC received quotations from two (2) suppliers namely; 1.) Arteestic Printshoppe and 2.) Stiches N' Wear Industries as stipulated in the abstract of the quotation;

Whereas, during the opening of bids, RO- 7 BAC considered the quotation submitted by Stiches N' Wear as the Lowest Calculated Quotation but did not check the specified requirements and did not provide an amount in words;

Whereas, upon careful evaluation, the RO7-BAC considered the quotation submitted by Arteestic Printshoppe as the next Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the RO7-BAC considered the quotation submitted by Arteestic Printshoppe as the Lowest Calculated and Responsive Quotation (LCRQ) as it meets the specified requirements;

*Now, **THEREFORE**, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement of Token during the Creative Industries Satellite Accounts Phase 2 Focus Group Discussions (FGDS) on Creative Economy of Visayas Cluster on 26 November 2024 be awarded to **Arteestic Printshoppe**.*
