RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF VENUE WITH ACCOMMODATION AND FOOD (AM & PM SNACKS,
BUFFET BREAKFAST, BUFFET LUNCH AND BUFFET DINNER) DURING CONDUCT OF THE
SECOND LEVEL TRAINING ON DATA PROCESSING SYSTEM (DPS) AND 2022 PHILIPPINE
STANDARD COMMODITY CLASSIFICATION (PSCC) FOR 2024 COMMODITY FLOW SURVEY
ON 20-22 JANUARY 2025 BE AWARDED TO GOLDEN PRINCE HOTEL AND SUITES

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Venue with Accommodation and Food (AM & PM snacks, buffet breakfast, buffet lunch and buffet dinner) during conduct of the Second Level Training on Data Processing System (DPS) and 2022 Philippine Standard Commodity Classification (PSCC) for 2024 Commodity Flow Survey on 20-22 January 2025;

Whereas, the Purchase Request (<u>PR No.0700-2025-01-003</u>) with an Approved Budget of Contract (ABC) of Eighty-Six Thousand Seven Hundred Pesos Only (Php86,700.00) was received by R07-BAC Secretariat on 08 January 2025;

Whereas, this procurement is done through Lease of Venue;

Whereas, the RO-7BAC received quotations from four (4) suppliers namely; 1) Golden Prince Hotel and Suites, 2) Goldberry Suites and Hotel Cebu, 3) Alpa City Suites, and 4) One Central Hotel and one (1) acknowledgement receipt from Noble Hotel and one (1) not available from Deped Ecotech Center a government-owned establishment as stipulated in the abstract of the quotation;

Whereas, during the opening of bids, the RO7-BAC considered the quotation submitted by Goldberry Suites & Hotel Cebu as the Lowest Calculated Quotation (LCQ);

Whereas, the quotation submitted by Goldberry Suites & Hotel Cebu was disqualified due to the non-availability of accommodation on 19 January 2025;

Whereas, the RO7-BAC proceeded to the next Lowest Calculated Quotation (LCQ) which is Golden Prince Hotel and Suites;

Whereas, after further bid evaluation, the RO-7 BAC declares Golden Prince Hotel and Suites with the Lowest Calculated and Responsive Quotation (LCRQ);

**Now, THEREFORE,** be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to the Head of the Procuring Entity (HoPE) that the Procurement of Venue with Accommodation and Food (AM & PM snacks, buffet breakfast, buffet lunch and buffet dinner) during conduct of the Second Level Training on Data Processing System (DPS) and 2022 Philippine Standard Commodity Classification (PSCC) for 2024 Commodity Flow Survey on 20-22 January 2025 be awarded to **Golden Prince Hotel and Suites.**
