RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE
PROCUREMENT OF VAN RENTAL DURING THE CREATIVE INDUSTRIES SATELLITE
ACCOUNTS PHASE 2 FOCUS GROUP DISCUSSIONS (FGDS) ON CREATIVE ECONOMY OF
VISAYAS CLUSTER ON 26 NOVEMBER 2024 BE AWARDED TO FJD TRANSPORT SERVICES

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to procure Van rental during the Creative Industries Satellite Accounts Phase 2 Focus Group Discussions (FGDS) on creative economy of Visayas Cluster on 26 November 2024;

Whereas, the Purchase Request (<u>PR No.0700-2024-11-079</u>) with an Approved Budget of Contract (ABC) Fifteen Thousand Pesos Only (Php15,000.00) was received by R07-BAC Secretariat on 11 November 2024;

Whereas, as approved by HOPE thru ROBAC Resolution No.0700-2024-11-R853 dated 12 November 2024, this procurement was done through Small Value Procurement;

Whereas, this procurement was posted on 15 November 2024 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11481517, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;

Whereas, RO-7BAC received quotations from two (2) qualified suppliers namely; 1.) Horizon Transport Tour and Rent a Car Corp. and 2.) FJD Transport Services and one (1) acknowledgement receipt from 1.) Ports of Cebu Transport Cooperative as stipulated in the abstract of the quotation;

Whereas, during the opening of bids, RO-7 BAC considered the quotation submitted by FJD Transport Services as the Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the RO-7 BAC declares FJD Transport Services with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, the members of R07-BAC present during the deliberation unanimously recommend to HOPE that the Procurement Van rental during the Creative Industries Satellite Accounts Phase 2 Focus Group Discussions (FGDS) on creative economy of Visayas Cluster on 26 November 2024 be awarded to **FJD Transport Services**.
