**RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) FOR THE PROCUREMENT OF VENUE INCLUDING ROOM ACCOMMODATION AND MEALS (AM & PM SNACKS, BUFFET BREAKFAST, LUNCH, AND DINNER) DURING THE BACK TO BACK 2025 BUDGET PREPARATION WORKSHOP AND RBAC REFRESHER COURSE ON PROCUREMENT ON 20-22 NOVEMBER 2023, 2023 REGIONAL PLANNING WORKSHOP ON 22-24 NOVEMBER 2023 AND 2023 GENERAL ASSEMBLY ON 25 NOVEMBER 2023 OF THE PHILIPPINE STATISTICS AUTHORITY RSSO-VII BE AWARDED TO VISTA MAR BEACH RESORT & COUNTRY CLUB.**

*Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 is in need to procure of Venue including Room Accommodation and Meals (AM & PM snacks and buffet breakfast, lunch and dinner) during the Back to Back 2025 Budget Preparation Workshop and RBAC Refresher Course on Procurement on 20 -22 November 2023, 2023 Regional Planning Workshop on 22 - 24 November 2023 and 2023 General Assembly on 25 November 2023 of Philippine Statistics Authority Region VII;*

*Whereas, an approved Purchase Request with **PR No.0700-2023-10-091** was received by the R07-BAC Secretariat;*

*Whereas, the Approved Budget for the Contract (ABC) for the said procurement is **ONE MILLION SIX HUNDRED EIGHTY PESOS ONLY (Php1,680,000.00)**;*

*Whereas, this procurement was done through Alternative Method of procurement-Lease of Venue;*

*Whereas, the Region 7 Bids and Awards Committee (R07-BAC) received Eleven (11) qualified bid forms from registered establishment namely: (1) Tag Concession Services Inc. (2) Vista Mar Beach Resort & Country Club (3) Lamac Multipurpose Cooperative, (4) Alta Cebu Village Garden Resort, INC. (5) Savoy Hotel Mactan Newtown, (6) Deped Ecotech Center, and five (5) who acknowledged only namely: (1) Bai Hotel Cebu, (2) Golden prince Hotel & Suites (3) The Noble Cebu Hotel (4) Marco Polo Plaza Cebu and (5) Pulchra Resorts;*

*Whereas, the Region 7 Bids and Awards Committee (R07-BAC) with the presence of the member of the Technical Working Group (TWG) conducted a deliberation on 16 November 2023 using virtual platform (messenger group chat);*

*Whereas, during the opening of bids, R07-BAC declared Vista Mar Beach Resort & Country Club and Lamac Multipurpose Cooperative as the Lowest Calculated Quotation (LCQ) having the same quotation of bid;*

*Whereas, the Region 7 Bids and Awards Committee (R07-BAC) declares Vista Mar Beach Resort & Country Club as the Lowest Calculated Quotation (LCQ) by virtue of proximity and advantage in the transportation and travel since it is only located*

in Lapu- Lapu City, subject for TWG onsite verification as first-time engagement, inspection of facilities in relation to the activities in the program, if they can comply with the stated specifications in the RFQ;

**Whereas**, a verification was conducted and the result was presented by the TWG to the R07-BAC on 17 November 2023 that Vista Mar Beach Resort & Country Club is responsive on the laid technical and documentary specifications;

**Whereas**, after thorough evaluation, the R07-BAC declared the quotation submitted by Vista Mar Beach Resort & Country Club as the Lowest Calculated and Responsive Quotation (LCRQ);

**NOW, THEREFORE**, be it resolved as it is hereby resolved that the members of the Region 7 Bids and Awards Committee (R07-BAC) who are present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the procurement of Venue including Room Accommodation and Meals (AM & PM snacks and buffet breakfast, lunch and dinner) during the Back to Back 2025 Budget Preparation Workshop and RBAC Refresher Course on Procurement on 20 -22 November 2023, 2023 Regional Planning Workshop on 22 - 24 November 2023 and 2023 General Assembly on 25 November 2023 of Philippine Statistics Authority Region VII be awarded to Vista Mar Beach Resort & Country Club.
