RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) FOR THE
PROCUREMENT OF VENUE WITH MEALS FOR UPDATING OF NEW LAWS
/MEMORANDUM AND DATA DISSEMINATION FUROM BE AWARDED TO GOLDEN
PRINCE HOTEL & SUITES.

Whereas, the Philippine Statistics Authority (PSA)-Regional Statistical Services Office 7 needs to procure Venue with meals for Updating of New Laws/Memorandum and Data Dissemination Forum;

*Whereas, the Purchase Request (PR No. 0700-2025-01-010) with an Approved Budget of Contract (ABC) of **Forty-Eight Thousand Pesos Only** (Php48,000.00) was received by Regional Office 7 Bids and Awards Committee (R07-BAC) Secretariat on 30 January 2025;*

Whereas, as approved by Head of the Procuring Entity (HOPE) through R07-BAC Resolution No. 0700-2025-02-R048A dated 05 February 2025, this procurement was done through Lease of Venue;

Whereas, R07-BAC received quotations from five (5) qualified suppliers namely; 1.) Golden Prince Hotel & Suites 2.) Alas de Angel Hotel and Resort Corporation 3.) DepEd Ecotech Center and two (2) who acknowledged only namely 1.)Cebu Parklane International Hotel and 2.)Eastland Hotel and Residences;

Whereas, the R07-BAC conducted a deliberation on 19 February 2025 at PSA RSSO 7;

Whereas, during the opening of bids, the R07-BAC considered the quotation submitted by Golden Prince Hotel & Suites as the Lowest Calculated Quotation (LCQ);

Whereas, after evaluation, the R07-BAC declares Golden Prince Hotel & Suites with the Lowest Calculated and Responsive Quotation (LCRQ);




