RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC)
RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) FOR THE

**Whereas**, the Philippine Statistics Authority (PSA)-Regional Statistical Services Office 7 needs to procure Venue with meals for Updating of New Laws/Memorandum and Data Dissemination Forum;

DepEd Ecotech Center and two (2) who acknowledged only namely 1.)Cebu Parklane International Hotel and 2.)Eastland Hotel and Residences;

Whereas, the RO7-BAC conducted a deliberation on 19 February 2025 at PSA RSSO 7:
