RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THAT THE PROCUREMENT OF PRINTING OF COMMODITY FLOW SURVEY (CFS) QUESTIONNAIRE AND OTHER PRINTED MATERIALS BE AWARDED TO MYBAÑEZ PRINTING PRESS

Whereas, Philippine Statistics Authority (PSA) - Regional Statistical Services Office 7 needs to Printing of Commodity Flow Survey (CFS) Questionnaire and other Printed Materials;

Whereas, the Purchase Request (<u>PR No.0700-2025-03-024</u>) with an Approved Budget of Contract (ABC) Two Thousand Four Hundred Pesos Only (Php2, 400.00) was received by Regional Office 7 Bids and Awards Committee (R07-BAC) Secretariat on 15 March 2025;

Whereas, as approved by the Head of the Procuring Entity (HOPE) through RO7-BAC Resolution No. 0700-2025-02-R047A dated 05 February 2025, this procurement was done through Small Value Procurement;

Whereas, this procurement was posted on 20 March 2025 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11906976, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;

Whereas, RO7-BAC received quotations from three (3) suppliers namely: 1) MYbañez Printing Press, 2) DMC Busa Printshoppe, and 3) L.G Copy Express as stipulated in the abstract of the quotation;

Whereas, during the opening of bids, RO7-BAC considered the quotation submitted by MYbañez Printing Press as the Lowest Calculated Quotation (LCQ);

Whereas, after further bid evaluation, the RO7-BAC declares MYbañez Printing Press with the Lowest Calculated and Responsive Quotation (LCRQ);

Now, THEREFORE, be it resolved as it is hereby resolved, the members of Regional Office 7 Bids and Awards Committee (R07-BAC) present during the deliberation unanimously recommend to the Head of the Procuring Entity (HOPE) that the Procurement of Printing of Commodity Flow Survey (CFS) Questionnaire and other Printed Materials be awarded to **MYbañez Printing Press**.
