The ePhillD refers to the digital version of the PhillD which may be printed on a piece of paper or may be stored in the mobile device. It is a proactive strategy of the PSA that will allow more Filipinos to immediately enjoy the benefits of being PhilSys-registered.


Like the PhillD card, the ePhillD is not a temporary ID, has no expiration and shall be honored and accepted in all transactions requiring proof of identity and age as enumerated in Section 13 of Republic Act No. 11055 consistent with Executive Order No. 162, s. 2022, subject to proper authentication.







The ePhilID QR code



The ePhilID QR Code contains demographic information and a front-facing photo of the person.

It also uses public-private key cryptography to ensure that the information in the QR Code cannot be tampered with.

The ePhilID QR Code cannot be scanned using ordinary QR Code scanner applications.

Acceptance



The ePhilID shall be honored as the official government-issued identification document of a person.



An ePhilID photocopied or saved on the citizen's phone mobile is acceptable, subject to authentication.



The demographic information indicated in the ePhilID should match what is embedded in its QR Code.



Penalty

Section 19 of the Republic Act No. 11055 or the Philippine Identification System Act of 2018 states that any person or entity who without just and sufficient cause, shall refuse to accept, acknowledge and/or recognize the PhilID or PSN, subject to authentication, as the only official identification of the holder/possessor thereof shall be fined in the amount



b. The penalty of three (3) to six (6) years imprisonment and a fine of One million (P1,000,000.00) to Three million pesos (P3,000,000.00) shall be imposed upon any offender found guilty of any of the following acts or omissions: (d) The use of the PhillD/PSN or unauthorized possession of a PhillD, without any reasonable excuse by any person other than the one whom it was issued or the possession of a fake, falsified, or altered PhillD; or, (e) The willful transfer of the PhillD or the PSN to any other person.
