RESOLUTION OF THE REGION 7 BIDS AND AWARDS COMMITTEE (R07-BAC) RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) FOR THE PROCUREMENT OF REGULAR SUPPLIES FOR THE 4TH QUARTER OF 2024 OF PSA RSSO VII FOR ADMINISTRATIVE AND STATISTICAL MATTERS FOR LOT- 2 JANITORIAL SUPPLIES BE AWARDED TO VISAYAN EDUCATIONAL SUPPLIES CORPORATION.

Whereas, the Philippine Statistics Authority (PSA)-Regional Statistical Services
Office 7 needs to procure Regular Supplies for the 4th Quarter of 2024 of PSA RSSO
VII for Administrative and Statistical Matters for Lot-2 Janitorial Supplies;

Whereas, the Purchase Request (PR No. 0700-2024-09-062) with an Approved Budget of the Contract (ABC) for Lot -2 Janitorial Supplies of Eighteen Thousand Four Hundred Pesos Only (Php18,400.00) was received by R07-BAC Secretariat on 17 September 2024;

Whereas, as approved by HOPE thru RO7-BAC Resolution No. 0700-2024-09-R692 dated 25 September 2024, this procurement was done through Shopping;

Whereas, this procurement was posted on 27 September, 2024 at the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no.11295162, Philippine Statistics Authority (PSA) website, and in at least one (1) conspicuous place;

Whereas, RO7-BAC received quotations from five (5) qualified suppliers namely; 1.) JCE Marketing 2.) Visayan Educational Supply Corporation 3.) BQE Office School Supplies Trading 4.) SDSM Trading and 5.) Triple- K Non- Specialized Wholesale Trading;

Whereas, the Region 7 Bids and Awards Committee (R07-BAC) with the presence of the member of the Technical Working Group (TWG) conducted a deliberation on 9 October 2024;

Whereas, during the opening of bids, the R07-BAC considered the quotation submitted by Visayan Educational Supplies and Corporation as the Lowest Calculated Quotations (LCQ) subject for TWG, for the clarification as to the number of pieces per bundle being offered on item 2.3 Microfiber Cleaning Cloth (RAGS) in the Request for Quotation (RFQ);

Whereas, a verification was conducted through phone call and the result was presented by the TWG to the R07-BAC on 6 November 2024 per TWG Evaluation Report marked as "Annex A" and forms the integral part hereof;
